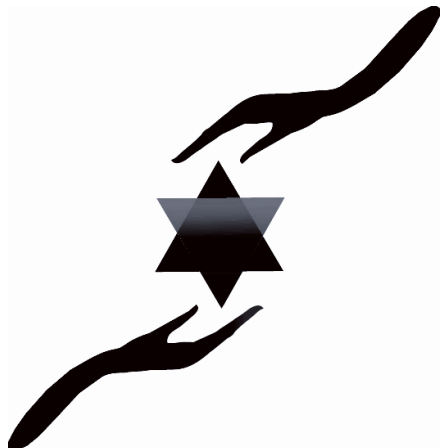

2007 Distribution List

Soldiers wounded in Lebanon war in summer 2006

- 1. Denis T. (26)** – reserve soldier; broken spine injury, was immobile for a long time - without money or help. Awaits spine surgery, moves around the house with a cane. Repatriated to Israel at age 13 with a grandmother, who later died; very lonely. **\$1800**
- 2. Ruslan B.** – injured in both legs, awaits surgery on the right knee. Not clear whether he will be to walk or work again. Married with 5-year old daughter; wife does not work. **\$500**
- 3. Aaron S.** – reserve soldier; serious injury of the left shoulder, concussion; likely to undergo 2-3 more surgeries and remain handicapped. Three children, (3 to 8 years old); wife resigned from work to take care of the husband and children. **\$500**
- 4. Victor K. (20)** – paratrooper soldier; the only child who forced his parents to let him serve in a fighting unit. Multiple serious injuries and shrapnel wounds; was expecting a seventh surgery in Dec. 2006. **\$500**
- 5. Gad V. (36)** – reserve soldier; multiple shrapnel injuries in the left side of the body - leg, arm, ear and eye. Significant muscle loss and the loss of sensation in the leg. Wife, a computer programmer, lost her job after spending several weeks in the hospital with Gad. Two children, 1.5 and 3.5. **\$500**
- 6. Idan B. (25)** – reserve soldier; broken upper jaw and nose, broken left leg and fingers of the right hand; loss of sensitivity in the leg. Shards remain all over the body. Had another surgery in January 2007. **\$500**
- 7. Roi H. (23)** – reserve soldier; serious injuries of the left leg, shoulder and back. In October 2006 still had 60% disability. **\$300**
- 8. Lev M. (28)** – reserve soldier; stayed in the hospital with injuries for three weeks, shard still remain in right hip; broken ear drums, complete hearing loss in the right ear, suffers from headaches and dizziness. **\$300**
- 9. Alexander L. (21)** – served in the Golani Brigade as a nurse soldier. Was severely injured in both eyes. Original surgery took 5 hours. Currently only one eye can see. **\$900**
- 10. Or B. (20)** - was injured in the legs when his tank was hit by an anti-tank missile resulting in amputation of both legs to the knee. **\$800**

- 11. Boris Z. (30)** – reserve soldier, served in Lebanon; was wounded in the left arm and both legs, sustained severe burns on the left side of the body. **\$1000**
- 12. Dmitry K. (32)** – was wounded on August 9, 2006 – first in the back, then during rescue under the fire - in the stomach. Barely survived, had two surgeries. Shards still remain in kidney and internal organs. Faces long and difficult recovery. Permanent disability is likely. Married, has 3 year old daughter. **\$500**
- 13. Eugene G. (24)** – very seriously wounded on August 6, 2006. Over 1000 shards all over the body, badly damaged right leg: due to the damage of main artery it did not have blood circulation, gangrene has started and over one third of the leg muscle had to be removed to stop the process. **\$400**
- 14. Shimon I. (27)** – severely wounded 8/9/2006 in Lebanon in the right leg, had two surgeries. One shard still remains; suffers from PSD. **\$500**
- 15. Roe Z. (23)** – was badly burnt all over, will require multiple surgeries, traveled to Boston for treatment. **\$500**
- 16. Neri B.-S. (26)** – was an officer in a paratrooper unit; was severely wounded on August 10, 2006: suffered from brain damage, brain hematoma, fracture in eye socket, tore of main nerve on left leg. Was paralyzed on his right side for four months and was confined to a wheel chair. **\$500**
- 17. Thomas S.** – draft soldier, serious abdomen wounds, underwent multiple surgeries. **\$500**

Civilian victims of war and terror

- 18. Purim Y. (37)** – husband **Yakov Y. (40)** was killed by Kassam rocket in Sderot while at work in summer 2006. Purim worked as a janitor in a supermarket; after the death of her husband she had to resign due to severe depression. Two children: Solomon, 13 and Hanaan, 12. Very needy family. **\$1000**
- 19. Karen A.** – husband, **Amil A. (32)** died in the bombing of the bakery in Eilat on January 29, 2007. The family has two children. **\$800**
- 20. Shani S.** – husband, **Michael Ben S. (27)** died in the bombing of the bakery in Eilat on January 29, 2007. The family has one child. **\$800**
- 21. Galina G. (43)** – lost a leg in the bombing in Haifa in summer 2006. Came to Israel 1.5 years ago with a husband (63), before the accident Galina worked as a janitor in a supermarket, her husband was cleaning streets; very needy. **\$800**
- 22. Tatiana K.** – single mother of three; was severely injured by a bomb in Haifa in July 2006 (multiple shards injuries of internal organs). Children (Irena, 16, Vladimir, 17) suffered tremendous hardships while Tatiana was in the hospital for over three months, as they did not have any income at all. The oldest daughter is married with a child. **\$1000**
- 23. Albert G. (64)** – severely injured in the head by Kassam rocket in Sderot on October 13, 2006; suffered sight and hearing loss. Was in the hospital for over a month; needs assistance. **\$500**
- 24. Anna V. (mid-60's)** - Anna was severely injured by a rocket that hit their house in Sefad during the war in summer 2006, her husband Leonid was also lightly injured. **\$500**
- 25. Marina Z. (21)** - badly injured in the head in Delphinarium bombing 6/1/2001; had multiple neurosurgeries, metal shards still remain in the head. Suffers from depression, PTSD and severe headaches. Recently, in April 2007, lost her job; there was no money to pay college tuition (Marina goes to school at night). **\$500**
- 26. Larisa A. (21)** – injured in Delphinarium bombing 6/1/2001; mother died of cancer 6/1/2003. Suffers from severe depression. **\$500**
- 27. Yury A. (56)** – seriously injured in Netania bombing 5/18/2001, 100% disabled; lives alone. **\$500**
- 28. Ester H.** – husband **Roman (37)** was killed in a bus bombing in Jerusalem in January 2004. Ester was left with three young children – 3 year old twins and one year old boy. **\$400**
- 29. Boris G. (36)** – wife Larisa, 36 is in coma since bombing at Hadera market on 10/25/2005; three children 12, 5 & 4. **\$800**
- 30. Ruth Z.** – was hit by Quassam rocket in spring of 2004 as she was going to the daycare with her 3-year old son. Her son was killed, Ruth lost one leg, and the second one was badly damaged. She spent 10 month in the hospital; just started to make first steps again in early 2006; lives alone. **\$500**
- 31. Susannah O.** – husband **Oshri O. (36)** was killed by Quassam rocket in Sderot on May 27, 2007. Susannah was six month pregnant with the second child at the time. **\$700**
- 32. Elian S. (13)** – lives in the town of Sderot under continuous bombardment of Quassam rockets. The family is very needy (two more children, neither parent works) and cannot afford Bat Mitzvah celebration for Elian. The money came from a Bat Mitzvah girl who lives in Greater Boston area. **\$400**
